# CLEAN EDGE ANNOUNCES SEMI-ANNUAL STOCK INDEX CHANGES FOR QGRD™, HHO™, GHHO™, CELS™, AND GWE™

**Portland, OR, September 22, 2025** — Clean Edge, Inc. today announced the results of the semi-annual evaluation of the following indexes:

- Nasdag OMX Clean Edge Smart Grid Infrastructure™ Index (QGRD™)
- <u>ISE Clean Edge Water™ Index</u> (HHO™)
- Nasdaq Clean Edge Global Water™ Index (GHHO™)
- Nasdaq Clean Edge Green Energy™ Index (CELS™)
- ISE Clean Edge Global Wind Energy™ Index (GWE™)

Unless otherwise noted, all changes became effective prior to today's market open as a result of the semi-annual evaluation.

Exchange-traded funds (ETFs) based on the indexes are offered by First Trust in the U.S. and Europe under the ticker symbols GRID, FIW, H20, QCLN, and FAN, respectively. All U.S. and global tracking financial products of Nasdaq Clean Edge indexes exceed \$6.5 billion in assets under management as of September 15, 2025.

## Nasdaq OMX Clean Edge Smart Grid Infrastructure Index (QGRD):

The following securities have been added to the QGRD Index: Astor Enerji A.S. (Istanbul: ASTOR.E), BELIMO Holding AG (Swiss: BEAN), BKW AG (Swiss: BKW), Contemporary Amperex Technology Co., Ltd. (Hong Kong: 3750), LS Eco Energy Ltd. (Korea: 229640), SAP SE (Xetra: SAP), and Takaoka Toko Co., Ltd. (Tokyo: 6617). No securities were removed as a result of the latest evaluation.

The Nasdaq OMX Clean Edge Smart Grid Infrastructure Index is designed to act as a transparent and liquid benchmark for the smart grid and electric infrastructure sector. The Index includes companies that are primarily engaged and involved in electric grid; electric meters, devices, and networks; energy storage and electric vehicle network management; and enabling software used by the smart grid and electric infrastructure sector. The securities must also meet other eligibility criteria including minimum requirements for market capitalization and average daily dollar trading volume. The Nasdaq OMX Clean Edge Smart Grid Infrastructure Index is evaluated semi-annually in March and September.

The Index is the basis for the <u>First Trust Nasdaq® Clean Edge® Smart Grid Infrastructure Index Fund</u> (GRID), which seeks investment results that correspond generally to the price and yield of the Nasdaq OMX Clean Edge Smart Grid Infrastructure Index before fees and expenses.

An alternate version of the index, the Nasdaq OMX Clean Edge Smart Grid Infrastructure Exclusions™ Index (QGRDE™), incorporates an ESG screening methodology identified and applied by Morningstar Sustainalytics. The index is the basis for the First Trust Nasdaq® Clean Edge® Smart Grid Infrastructure UCITS ETF (GRDU).

## **ISE Clean Edge Water Index (HHO):**

There were no additions or removals from the HHO Index as a result of the latest evaluation.

The ISE Clean Edge Water Index is designed to track the performance of U.S.-listed companies that derive a substantial portion of their revenues from the potable water and wastewater industry. Industry exposure includes water distribution, infrastructure (pumps, pipes and valves), water solutions (purification and filtration), and ancillary services such as consulting, construction, and metering. The securities must also meet other eligibility criteria including minimum requirements for market capitalization and average daily dollar trading volume. Securities which meet eligibility criteria are then ranked in descending order by market

capitalization and the top 36 securities are selected as Index Securities. The ISE Clean Edge Water Index is re-ranked semi-annually in March and September.

The Index is the basis for the <u>First Trust Water ETF</u> (FIW), which seeks investment results that correspond generally to the price and yield of the ISE Clean Edge Water Index before fees and expenses.

## Nasdaq Clean Edge Global Water Index (GHHO):

The following securities have been added to the GHHO Index: Coway Co., Ltd. (Korea: 021240), Eurofins Scientific SE (Paris: ERF), Jacobs Solutions, Inc. (New York: J), Tetra Tech, Inc. (Nasdaq: TTEK), and Toray Industries, Inc. (Tokyo: 3402). The following securities have been removed from the Index: American States Water Co. (New York: AWR), Beijing Enterprises Water Group Ltd. (Hong Kong: 371), California Water Service Group (New York: CWT), Pennon Group Plc (London: PNN), and Reliance Worldwide Corp. Ltd. (Australian: RWC).

The Nasdaq Clean Edge Global Water Index (GHHO) is a modified equal-weighted Index designed to track the performance of companies that derive a substantial portion of their revenues from the potable water and wastewater industry, as defined by Clean Edge. Industry exposure includes water distribution, infrastructure (pumps, pipes, and valves), water solutions (purification and filtration), and ancillary services such as consulting, construction, and metering. Companies are also evaluated on the basis of their business activities, controversies, and ESG Risk Ratings. The Nasdaq Clean Edge Global Water index is re-ranked semi-annually in March and September.

The Index is the basis for the <u>First Trust Nasdaq® Clean Edge® Global Water UCITS ETF</u> (H2O), which seeks investment results that correspond generally to the price and yield of the Nasdaq Clean Edge Global Water Index before fees and expenses.

## Nasdaq Clean Edge Green Energy Index (CELS):

The following securities have been added to the CELS Index: ChargePoint Holdings, Inc. (New York: CHPT), Electrovaya, Inc. (Nasdaq: ELVA), and Enovix Corporation (Nasdaq: ENVX). The following security has been removed from the Index: ADS-TEC Energy Plc (Nasdaq: ADSE). Sunnova Energy International, Inc. (New York: NOVA) was removed intraquarterly on June 10, 2025.

The Nasdaq Clean Edge Green Energy Index is designed to track the performance of clean-energy companies that are publicly traded in the U.S. The Index includes companies engaged in the manufacturing, development, distribution, and installation of emerging clean-energy technologies such as solar photovoltaics, advanced batteries, hybrid and electric vehicles, and renewable materials. The four major sub-sectors that the index covers are Renewable Electricity Generation; Energy Storage & Conversion; Energy Intelligence; and Advanced Energy-Related Materials. The securities must also meet other eligibility criteria including minimum requirements for market capitalization, average daily share volume, and price. The Nasdaq Clean Edge Green Energy Index is re-ranked semi-annually in March and September.

The Index is the basis for the <u>First Trust Nasdaq® Clean Edge® Green Energy Index Fund</u> (QCLN), which seeks investment results that correspond generally to the price and yield of the Nasdaq Clean Edge Green Energy Index before fees and expenses.

## **ISE Clean Edge Global Wind Energy Index (GWE):**

The following securities have been added to the GWE Index: Dongfang Electric Corp. (Hong Kong: 1072), Sif Holding N.V. (Amsterdam: SIFG), and Unison Co., Ltd. (Korea: 018000). The following securities have been removed from the Index: Aker Horizons ASA (Oslo: AKH), Hexcel Corp. (New York: HXL), Owens Corning (New York: OC), and SGL Carbon (Xetra: SGL).

The ISE Clean Edge Global Wind Energy Index is designed to track the performance of companies that are primarily engaged and involved in the wind energy industry based on analysis of the products and services offered by those companies (including both pure-play companies focused on the wind energy sector and diversified multinationals with wind energy

sector exposure). The securities must also meet other eligibility criteria including minimum requirements for market capitalization and average daily dollar trading volume. The ISE Clean Edge Global Wind Energy Index is re-ranked semi-annually in March and September.

The Index is the basis for the <u>First Trust Global Wind Energy ETF</u> (FAN), which seeks investment results that correspond generally to the price and yield of the ISE Clean Edge Global Wind Energy Index before fees and expenses.
